

Talking Points

Advocacy Tips


Be concise and focused: Prepare a brief introduction and present your key points clearly. Think through your "elevator pitch" when meeting with your network or speaking with legislators.

Be respectful and professional: Maintain a positive attitude, listen actively, and address any concerns or questions raised. Remember to thank them for their time and consideration.

Follow up with a thank-you note: After the meeting, send a personalized thank-you note expressing your appreciation and reiterating your main points.

The Coalition for Transforming Higher Education Funding has several main talking points we want to convey. Below are a few of those talking points. Combine these points with your own story to make an impactful presentation.


- SB 3965 is a once-in-a-generation opportunity to fix funding for Illinois' public universities.
- With no current model for distributing state appropriations to public institutions, funding has been cut 46% since 2000 (even considering recent increases), shifting costs to students, particularly those who can least afford it.



• Enrollment has decreased by 15,000 students from 2012 to 2022, disproportionately impacting students of color and students from low-income backgrounds.

Talking Points, contd

- SB 3965 presents an opportunity for lawmakers to make Illinois universities equitable, accessible and affordable, ensuring all institutions and their students can thrive.
- SB 3965 provides:
 - **Adequacy**: Funding allocation is calculated based on each university's unique mission along with the needs of the students that each university enrolls, grounded in costs of additional academic and non-academic supports.
 - **Equity**: More funding is driven to support underrepresented students and the universities that disproportionately enroll them. Universities that are farthest from adequate funding are prioritized in new state spending.
 - Stability: Institutional success in the long run is maintained with a hold-harmless provision and mechanisms to address rising costs for universities. The Commission's equitable funding formula gets all universities to adequate funding within 10-15 years, if lawmakers pass an additional \$100 - 135M in funding per year.
 - **Accountability**: The model will bring a new framework for accountability that aligns funding to improvements in spending, affordability, enrollment, outcomes, and state and institutional goals.
- The goal of the Adequate and Equitable Funding Formula is to ensure that all public universities get a funding increase each year, closing the gap between their current funding and the actual funding they need to serve their students.



Talking Points, contd

Passing and funding SB 3965 will result in an estimated:

- \$1.4 billion in additional funding over 10-15 years to ensure all universities have adequate resources.
- Over 29,000 additional university graduates moving through the system.
- More than \$6.3 billion in additional state taxes paid over the lifetime of these graduates.
